Provisions:

1. Rules

- 1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS ISAF).
- 1.2. The following regulations as defined in the "Wettfahrtordnung des Österreichischen Segel-Verbands (OeSV) 2014", "Allgemeinen Segelanweisungen des OeSV 2014", sailing instructions (SI) and this NOR will apply.
- 1.3. Additionally the regulations as defined in the "Austragung von Landesmeisterschaften im Bereich des Landessegelverbandes Burgenland (LSV Bgld.), gültig seit 2004" will apply.
- 1.4. The regatta will be governed by the rules as defined in the "Anti-Doping-Bundesgesetzes 2007".
- 1.5. Appendix P of RRS will apply.
- 1.6. Rule changes will appear in full in the sailing instructions (SI). The SI may also change other racing rules.

2. Advertising

The Organizing Authority may require all boats to display advertising in accordance with ISAF Regulation 20. Such advertising shall be affixed in accordance with the SI and may not be changed or removed during the regatta without written approval of the Organizing Authority.

- 3. Eligibility requirements and Entry
 - 3.1. The regatta is open to boats of the Zoom8 class from all countries.
 - 3.2. Each participating boat shall be insured with valid third party liability insurance with adequate cover per event (minimum EUR 1.500.000).
 - 3.3. Competitors shall be a member of his/her Member National Sailing and Class Authority or one of its affiliated organizations.
 - 3.4. Competitors shall own a BFA Junior, BFA Binnen oder BFA FB 1 or an adequate document of their



Member National Authority.

- 3.5. Competitors shall not be older than 19 years until the end of 2014 the regatta.
- 3.6. Entries
 - 3.6.1. must be submitted online at http://www.uycns.at/uycns/regatten_meldung/2013_springcup until the regular end of entry,
 - 3.6.2. Entry fee has to be transferred until the regular end of entry,
 - 3.6.3. must be submitted by presenting the "Meldeformular" (last pages of this NOR) subscribed by the competitor and a liable person, either by law or authorized through a letter of attorney until the end of regular entry to dominic.marsano@uycns.at or present the document during the registration.
 - 3.6.4. Online-Entry leads to a payment obligation of the entry fee.
- 3.7. Late entries will only be accepted until the registration and leed to an additional fee of EUR 10,- per competitor.
- 3.8. Minimum amount of competitors
 - 3.8.1. There has top e a minimum of 10 competitors at the end of the regular entry, otherwise the regatta can be cancelled by the Organization Authority.
 - 3.8.2. To organize the "Landesmeisterschaft" there has been a minimum amount of 10 boats, an the fleet shall include 3 different clubs of the Burgenland.
 - 3.8.3. Please inform yourself on the webpage www.uycns.at approximately 5 days in advance of the regatta.
- 4. Entry Fee

- 5. Registration
 - 5.1. Control of the measurement certificate, third party liability, membership by the National Sailing Authority, Segelführerschein, correct entry, the subscription on the letter of attorney will be at the registration. The SI will be handed out during the registration. The registration will take place on 6th of June from 19.00 20.00 and on the 7th of June from 8.00 10.00 at the race-office of the UYCNs.
 - 5.2. Control oft he membership by the National Class Organization will be done by the Organizations itself.
- 6. Charter Boats

7. Opening and Coachmeeting

Opening will be on the 7th of June at 10.00 in the clubhouse of the UYCNs. Further coachmeetings will be announced on the notice board.

- 8. Start
 - 8.1. First starting signal on the 7th June not prior 11.00
 - 8.2. There will no starting signal on 9th of June later than 15.00.
 - 8.3. In the case, that on the 9th of June there is no Europacup constituted 8.2. will be overruled until the regatta is constituted.
- 9. Courses

The course will be a trapezoid course with an approximately time of 50 minutes.



10. Scoring

- 10.1. Europacup: 8 races are scheduled. When 4 races or fewer races have been completed, a boat's series score will be the total of her race score. When from 5 to 8 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- 10.2. Schwerpunktregatta and Landesmeisterschaft: 3 races are required to constitute a valid Schwerpunktregatta or a valid Landesmeisterschaft.
- 10.3. The Low-Point-Scoring system of RRS Appendix A will apply.

11. Team, Coach and Support Boats

Generally the usage of support boats is forbidden. Support Boats are only allowed with a special license and must be clearly marked with a yellow flag. Until the end of the regular entry, support boats must be registered through the UYCNs including the support boat number and the name of the driver(s) by email to dominic.marsano@uycns.at. For the special license a fee of EUR 20,- has to be paid by bank transfer (p. 4.) including the support boat number, the driver, the regatta. The fee includes one coach package (NOR, Programm, SI, ...). Support Boats will be part of the security arrangement of the event – details in the license.

12. Radio communication

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

13. Prices

- 13.1. Special prices for the first 3 boats.
- 13.2. Prices and souvenir for each competitor at the price giving ceremony.

14. Disclaimer of Liability

The responsibility for the decision of the person in charge to participate in a race or to continue with it is solely with him, to that extent he also takes the responsibility for his crew. The helmsman is responsible for the qualification and the correct nautical conduct of his crew as well as for the suitability and the transportsafe condition of the registered boat. In cases of Force Majeure or on grounds of administrative orders or for safety reasons the organizer is entitled to make changes in the realisation of the event or to cancel the event. In these cases there does not exist any liability for compensation of the organizer to the participant. In case of a violation of obligations that do not constitute primary respectively material contractual duties (cardinal obligations), the liability of the organizer, no matter because of which cause in law, for material and property damages of all kinds and their consequences that arise to the participant during or in connection with the participation in the event resulting from a conduct of the organizer, his representatives, servants or agents, is restricted to damages that were caused wilfully or grossly negligent. When a violation of cardinal obligations occurs, in cases of simple negligence the liability of the organizer is limited to foreseeable, typically occurring damages. To the extent that the liability for damages of the organizer is excluded or restricted, the participant also relieves the staff – employees and representatives, agents, servants, sponsors and individuals who provide or drive salvage, safety or rescue vessels or assist with their use - from the individual liability for damages, as well as also all other individuals who were instructed to act in connection with the realisation of the event. The effective racing rules of the ISAF, the class rules as well as the regulations of the Notice of Race and the Sailing Instructions are to be complied with and are expressly recognised. The Austrian law applies.

15. Insurance

Each participating boat shall be insured with valid third party liability insurance with adequate cover per event (minimum EUR 1.500.000).



16. Further information

16.1. Parking: cars and trailers

On the area of the UYCNs carparking is not allowed. All cars have to leave the clubarea right after uploading the trailer. Trailers have to be parked on specials areas. For caravans there is a special exeptance. A parking place together with electronic power will be granted at an amount of EUR 20,-. Further information about parking will be given at registration.

16.2. Accomodation
